Classroom Equipment	Install projectors in classrooms frequently used for seminars or larger classes to enhance learning.	Projectors were installed in key classrooms to facilitate seminars and lectures, improving visual engagement for larger classes.
Library Resources	Add a few more computers in the library for easy access to digital resources and for students who need research support.	Additional computers were added to the library's digital section, allowing more students access to e-books, journals, and online research materials.
Sports Facility	Improve sports facilities with basic equipment like volleyballs, nets, and areas for table tennis or chess to support recreational activities.	Sports equipment was procured, including volleyballs, nets, and tables for table tennis and chess, encouraging physical and recreational activities among students.
