## MEMORANDUM OF UNDERSTANDING

This **Memorandum of Understanding** (hereinafter called as the 'MOU') is entered into this on the **15th** day of **June, 2022**.

### BETWEEN

**Guru Gobind Singh Educational Society's Technical Campus (GGSESTC), Chas, Bokaro, Jharkhand** represented herein by its Director **Dr. Priyadarshi Jaruhar** (the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

### AND

**Hulladek Recycling Pvt. Ltd., Kolkata, West Bengal** represented herein by its CEO, **Mr. Nandan Mall** (firm which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

### WHEREAS:

- A) GGSESTC is a premier institution for engineering & management education in Jharkhand state founded in 2011 by Guru Gobind Singh Educational Society. The college is affiliated to JUT, Ranchi and approved by AICTE, New Delhi. At present the institute offers two courses; B.Tech. and MBA. The B.Tech. courses have branches in Mechanical, Civil, Computer Science, Electronics & Communication, and Electrical & Electronics engineering. The MBA program offers three specialization; Marketing, Finance, and HR. The serene campus of the college is located at NH-18 in Chas, Bokaro district of Jharkhand, towards Purulia.
- B) Hulladek Recycling Pvt. Ltd. is an electronic waste management firm registered with Central Pollution Control Board. It has been engaged in proper and safe collection, transportation, segregation, recycling and disposal of e-waste since 2015. E-waste includes electronic products made of metal, plastic, glass and could also include hazardous chemicals such as lead, cadmium and mercury. The registered head office of the firm

is located in Kolkata, West Bengal and has operations in Delhi, Mumbai, Bangalore, Jamshedpur, Agartala, Dimapur, Kohima, Guwahati and Bhubaneswar.

- C) The shared objective of this MOU is to put in compliance of E-Waste (Management) Rules, 2016 set up for management of Electronic Waste except liquid waste.

**NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:**

**DELIVERABLES FROM GGSESTC:**

- To sign required documents to acknowledge that E-Waste has been handed over to the Hulladek Recycling.
- GGSESTC will pay Rs. 3000/- (including GST) as agreement fee which includes E Waste Management Services, Awareness Sessions and E Waste Bin. Beside this GGSESTC don't have to give extra charges.
- To handover the E-Waste on "as is where is basis". GGSESTC is expected to generate 500 Kgs or more of E-Waste annually during each contractual term.
- To accumulate all E-Waste and inform to Hulladek Recycling once reasonable volume has accumulated.
- To ensure that all the E-waste procured by or in the possession of them will be exclusively given to Hulladek Recycling Pvt. Ltd.

**DELIVERABLES FROM HULLADEK RECYCLING PVT. LTD.:**

- To pick up, transport, carry and recycle/dispose of the E-Waste from GGSESTC as per the norms prescribed by the Government Authorities from time to time.
- To make available Utilization Certificate confirming that E-Waste provided has been recycled/disposed of as per the norms prescribed by the Government Authorities within 60 days of the pick up the E-Waste.
- To dispose of such equipment and specifically agreed that they will pay/charge towards the disposal of E-Waste. The pickups confirmed by the Hulladek Recycling will be carried out on a priority basis within one week from the date of request.
- To share records & data of the e-waste material procured.



- Hulladek Recycling shall install 1(One) "E-waste Collection Bin" of size 1 meter (Length), 0.8 Meter (Height) and 0.9 Meter (Width) at or any other location as may be prescribed by GGSESTC from time to time.
- Hulladek Recycling shall also offer a free replacement of the bin if necessary up to one year from the date of installation of the bin.
- Hulladek Recycling shall allow the students of GGSESTC to carryout internship or projects related to waste management and recycling in their facility.

### REPORTING

- The MOU and its undertakings will be reported and seen into by the under signed of this MOU.

### COMMERCIALS

- Monetary transactions for services are defined in this MOU under **Annexure 1.**

### DURATION

- This MOU will be valid for 3 years. This MOU shall become effective upon signature by the authorized and will remain in effect until modified or terminated by mutual consent.


