## MEMORANDUM OF UNDERSTANDING

This Memorandum of understanding (hereinafter called as the 'MOU') is entered into on this the 23<sup>rd</sup> day of August, 2021

BETWEEN

Guru Gobind Singh Educational Society's Technical Campus, Chas, Bokaro, Jharkhand represented herein by its Director Dr. Priyadarshi Jaruhar (hereinafter referred as "GGSESTC", the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in- office, administrators and assignees).

AND

Regional Office, Jharkhand Industrial Area Development Authority, Bokaro, Jharkhand represented herein by its Director, Ms. Keerthishree G, IAS (hereinafter referred to as "JIADA", authority which expression, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assignees).

GGSESTC and JIADA are individually referred to as "Party" and collectively as the "Parties".

### I. BACKGROUND

- ✚ GGSESTC, is a college of engineering & management founded in 2011 by Guru Gobind Singh Educational Society. The College is affiliated to JUT, Ranchi and offers branches in Mechanical, Civil, Computer Science, Electronics & Communication and Electrical & Electronic's engineering. The MBA program offers three specializations, Marketing, Finance and HR. The serene campus of the college is located at NH-32 in Chas, Bokaro district of Jharkhand, towards Purulia.
- ✚ JIADA has been constituted by the Government and is aimed for development of industrial area in the Jharkhand state. JIADA is responsible for acquisition of land, development of infrastructure and facilities like road, drainage, water supply, public utilities, etc. under their jurisdiction. The main objective of JIADA is to promote the industries like small, medium, large scale industries in order to ensure inclusive socio-economic growth in the state. The head office of JIADA is

located at Ranchi and is supported by regional offices at Adityapur, Bokaro, Ranchi and Dumka.

- ✚ GGSESTC has been closely associated with the industry of Bokaro and nearby region. GGSESTC has been actively engaged in research and consultancy and providing innovative solutions to the industries. Both GGSESTC and JIADA believe that close co-operation between the two would be of major benefit to the industrial society and academic community to enhance their competitiveness and productivity.
- ✚ The faculty members and budding graduates from GGSESTC could play a key role in the various projects taken up by JIADA, Bokaro and can make more effective use of their knowledge and skills.
- ✚ GGSESTC intends to cooperate and support JIADA, Bokaro to fulfil its objective. The students of GGSESTC will gain benefits by availing various learning opportunities under different JIADA initiatives.
- ✚ Both GGSESTC and JIADA, Bokaro being legal entities in themselves desire to sign this MOU for advancing their mutual interest.

## **II. PURPOSE & SCOPE**

### **JIADA, Bokaro:**

- ✚ Both GGSESTC and JIADA, Bokaro shall establish channels of communication and co-operation that will promote and advance their respective operations to achieve their Institutional objectives. They shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- ✚ Cooperation between GGSESTC and JIADA, Bokaro will facilitate effective utilization of the intellectual capabilities of the faculties of GGSESTC, providing significant inputs to them in developing suitable teaching/training systems, keeping in mind the needs of the industry. It will help the faculties of GGSESTC to suitably customize the course curriculum so that the students fit into the industrial scenario meaningfully.
- ✚ JIADA, Bokaro will permit the faculty members and students of GGSESTC to visit the industrial set-ups under its jurisdiction. Hence, the Students

of GGSESTC will get an opportunity to see and learn the application of the various technologies in industries.

**GGSESTC:**

- ✚ GGSESTC will provide its infrastructure and other required facilities inside its campus for the various programmes conducted by JIADA, Bokaro.
- ✚ GGSESTC shall plan and execute the Skill/Technology/Add on courses for in consultation with JIADA, Bokaro to prepare the professionals in line with the industrial needs.
- ✚ GGSESTC will help JIADA, Bokaro in providing interns and expertise to solve the below listed issues.
  - Conducting detailed survey of the BIADA Industrial Area in order to support effective functioning of the unit & keep reporting on the health status of the unit and come up with the solutions.
  - Conducting detailed survey of the BIADA Industrial Area in order to highlight electricity related issues and come up with the adequate solutions to resolve it.
  - Conducting detailed survey of the BIADA Industrial Area in order to chalk out the requirement of road connectivity/ maintenance and come up with the adequate solutions to resolve it.
  - Conducting detailed survey of the BIADA Industrial Area in order to identify the requirement of Street light connectivity/ maintenance and come up with the adequate solutions towards sustainable street light connectivity.
  - Conducting detailed survey of the BIADA Industrial Area in order to understand issues related to drainage connectivity/ maintenance and come up with the solution towards sustainable drainage system.
  - Conducting detailed survey of the BIADA Industrial Area in order to understand Pollution issues and come up with the solution towards sustainable resolution of these issues.

- Conducting detailed survey of the BIADA Industrial Area in order to understand the Revenue Collection procedure of industries and come up with the solutions for improving revenue collection.
- Conducting detailed survey of the BIADA Industrial Area in order to figure out scope of rain water harvesting, renewable energy in the BIADA industrial area, and come up with the solution for its effective implementation.
- Add other task as per need.

### **III. CONFIDENTIALITY CLAUSE**

- ✚ Both the Parties will not share any confidential information to anyone.

### **IV. FUNDING**

- ✚ This MOU is non-financial in its present form. This clause may be revised in future by BIADA, subject to terms and conditions based on the delivery of results.

### **V. MONITORING MECHANISM**

- ✚ Both the Parties will meet as often as possible in order to evaluate matters regarding the implementation of this MOU.

### **VI. LIMITATIONS**

- ✚ This MOU does not create any legal rights or obligations under any international or domestic law upon either Party.

### **VII. DISPUTE SETTLEMENT**

- ✚ Any dispute which may arise in connection with the implementation, interpretation or application of this MOU should be settled amicably between the Parties through mutual consultations.

### **VIII. FINAL PROVISIONS**

- ✚ This MOU commences on the date of its signing by the duly authorized representative of both the Parties.
- ✚ This MOU may be modified by the Parties by mutual consent. Such modifications should be made in writing.

- ✦ Either Party may discontinue cooperation under this MOU, but should endeavour to communicate with each other, with at least thirty (30) days in advance with written notice of its decision to end its participation in this MOU.
- ✦ In case of early discontinuation of this MOU, the Parties will endeavour but are not under obligation to complete any activity which has been commenced while the MOU was operative.
