- 3. The latest Approval Process Handbook 2024-25, page no 17 of AICTE, New Delhi, has made provision to facilitate the employed/ working professionals, by providing flexible time table to conduct theory and practical classes (even beyond office hours) and it will be treated as <u>regular courses</u> in B.Tech.-ME/EEE/Civil & MBA.
- 4. Working professionals with diploma qualifications enrolled in regular undergraduate programmes shall be allowed to do the theory and practical in flexible timing to enrich their skills and knowledge. The institute will provide the required facility to the students under this type of enrolment. Eligible graduate Working Professionals are allowed to do MBA.
