OFFICE ORDER

Subject: Mandatory Payment of Semester Fees by Students in case of Delay in E-Kalyan Scholarship Disbursement

It has been observed with concern that the E-Kalyan Scholarship amount is not being released in time by the concerned department, resulting in serious financial strain on Guru Gobind Singh Educational Society Engineering & Technical Campus (GGSESTC) and disruption of institutional financial planning.

While GGES is sympathetic to the genuine difficulties of students, it is made clear that the institution cannot be run on anticipated or uncertain scholarship releases.

Also as per the guidelines of E-Kalyan, now fee receipts are required to fill the E-Kalyan application.

After due consideration, the Management of Guru Gobind Singh Educational Society (GGES) hereby issues the following directions, which shall be implemented strictly with immediate effect:

1. Mandatory Fee Payment:-

All students of GGSESTC, including those eligible under the E-Kalyan Scholarship scheme, shall be required to deposit their semester fees within the prescribed due date, irrespective of scholarship disbursement status.

2. No Automatic Fee Waiver:-

Delay or non-release of E-Kalyan scholarship shall not be treated as a ground for non-payment or deferment of semester fees.

3. Late Fee Penalty:-

In case of failure to deposit the semester fees by the due date, a late fee fine of ₹100/- (Rupees One Hundred only) per day shall be levied until the full fee amount is paid.

4. Adjustment on Scholarship Receipt:-

Once the E-Kalyan scholarship amount is received, the same shall be adjusted against the fee already deposited, or refunded / credited as per institutional norms.

- Issue of admit cards
- Registration for examinations
- Declaration of results
- Access to institutional facilities

(as per rules of the University / AICTE, wherever applicable)

6. Responsibility of Administration:-

The Director / Principal, GGSESTC shall:

- a) Communicate this order clearly to all students and parents
- b) Display the notice prominently on notice boards and the college website
- c) Ensure uniform implementation without discrimination
- d) Maintain proper records for audit and compliance purposes

This order is issued in the larger interest of institutional financial discipline and sustainability and shall remain in force until further orders.
